**RESIDENTIAL TARIFFS EFFECTIVE FROM: 01/07/2018**

The City Of Tshwane approved a new pricing structure for the electricity, water and sanitation industry, designed to encourage more efficient electricity, water and sanitation use. Instead of charging a flat rate for your consumption, the new system applies a stepped tariff that will mean the price of electricity, water and sanitation increases drastically as the level of consumption increases.

Each billing period we take a meter reading at your property to check how many kWh electricity and how many kilolitres of water and sanitation have been used since your last meter reading. With the new applied energy law, Global International must calculate your total usage by applying the step tariffs as stipulated below. Please note that all prices reflecting below includes 15% VAT.

For a connection with a conventional meter, energy consumed since the previous meter reading is charged for per month or part of a month, and for a prepaid meter the energy charged for all kWh purchased in a thirty day period is the following per kWh:
